Community Meeting Minutes June 25, 2018, 7:00pm Heritage Community Church

- I. Roll Call / Certification of Proxies
 - a. Meeting began at 7:05pm.
 - b. Verified all homeowners present were accounted on the sign-in sheet.
 - c. Homeowners who submitted proxies but were present were returned their proxy.
 - d. 35 homeowners present in person or via proxy; 35 homeowners eligible to vote. Quorum (25%, or 25 eligible homeowners) achieved.
- II. Proof of Notice of Meeting
 - a. Mailing to homeowners on June 11, 2018
 - b. Spring/summer newsletter to homeowners on June 11, 2018
 - c. Email sent on June 19, 2018
 - d. Email sent on June 24, 2018

III. Officer Reports

- a. President
 - i. Anne Arundel County fire marshal has been posting no parking signs on streets less than 24' wide. This would apply to some of the Colonial Park streets, though no signs have been posted. Lynnette has approached the County Council and the County Executive.
- b. Vice President
 - i. A number of deer have been spotted in the neighborhood; please be careful when driving.
 - ii. Sidewalk near a couple drains has been reported to the County for repair.
- c. Secretary/Treasurer
 - i. A copy of the Community's 2017 December financial report was available to homeowners. A brief review and discussion occurred.
 - ii. HOA 2017 financial reports were audited and minor accounting changes were made; otherwise, no concerns were noted. The audit is available for review by any eligible member of the Association.
 - iii. A copy of the Community's 2018 May YTD financial report was available to homeowners. A brief review and discussion occurred.
 - iv. A summary of the Community's assessment delinquency was provided. As of May 31, 2018, seven homeowners were in arrears greater than 60 days, with the vast majority of the delinquent balance attributable to two homeowners. Discussion revolved around the actions (including, but not limited to, judgments, liens, and foreclosure) that are being employed to collect on past-due accounts. Four of the delinquent accounts are in the process of being paid.

- v. One homeowner filed for bankruptcy but failed to continue submitting quarterly assessment payments. Our collections attorney contested the legitimacy of the bankruptcy claim and the court dismissed the bankruptcy claim.
- vi. In follow-up to the question posed during the November 2017 meeting, the Board can and has publicly posted homeowners in arrears. HOA documents do permit this practice.

- a. Solicitation of additional candidates no new candidate self-identified.
- b. Since only three candidates for three slots, no community address, inspectors of election and election of directors required.
- c. Election of Directors Matt Lautzenheiser, Lynnette Shutty and Rich Westover were elected to the Board.

VII. Unfinished Business

- a. Open space planning Board continues to want to enhance our open spaces. No additional actions have yet occurred. Homeowners who are interested in helping this initiative are requested.
- b. Dog excrement concerns This continues to be a community-wide issue. Board will issue fines (\$25) to homeowners who do not clean up after their dog. Also concern that homeowners from Colonial Woods are using the Phase III common area and not picking up after their dogs.
- c. Speeding / speed bump installation Rick Savageau suggested the creation of a safety chair or committee.
- d. Phase III "No Parking" signage some homeowners have complained about street parking at the intersection of Governor Johnson and Garfield Avenue. Board is exploring the possibility of posting "no parking" signage at that intersection.

e. Maglev – The developing plans for the maglev train do not affect Colonial Park. Plans have been limited to paths along the Baltimore-Washington Parkway.

VIII. New Business

- a. Community compliance walk-through will be conducted and homeowners notified of violations.
- b. Anne Arundel County Fire Marshal street parking see "President's Report" above.
- c. Multiple family occupancy discussion occurred regarding concerns that a couple homes are housing more than one family, in violation of HOA rules. Board has successfully resolved violations and will use our attorney as needed.
